



# SHRM Certification Questions & Answers!

Q: When will my recertification period end?

A: Your recertification cycle beings the day you passed the exam or completed all the requirements for the Online Tutorial Pathway. Your recertification period ends on the last day of your birth month.

Example:

Took Exam - May 2015
Birth Month - July
Recertification Period = May 2015 July 2018

**Q:** Amy what is your greatest HR achievement?

A: My greatest HR achievement has been the conversion to a new Human Resources Information System as part of our organization's implementation of a new enterprise system university wide. This was a years-long project that involved a team of people including several departments on campus. We converted all our payroll data to the new system, and we analyzed most of HR policies in order to implement them within the parameters of our new software. It was a great experience of learning all the ins and outs of our department in order to analyze and implement.

### ASK DAVE THE "FORM I-9/E-Verify" EXPERT???



QUESTION: Do I need to show my employer one or two documents?

ANSWER: It depends. Some employees choose to show one document from "List A" to prove both identity and work authorization. Other employees choose to show a combination of documents - one from "List B" showing their identity and one from "List C" showing work authorization. For the complete list of documents that you can use, look at the List of Acceptable Documents.
